
DOES MY EXPERIENCE QUALIFY FOR CFP® CERTIFICATION?

Use this flowchart to find out if your current professional role is likely to qualify for the CFP® certification experience requirement — or go straight to your account at CFP.net/ReportExperience and enter your hours to see how many you've already accrued!



If you're still not sure whether your experience qualifies, report it in your CFP Board account at CFP.net/ReportExperience to find out. You will not be penalized or disqualified from earning CFP® certification if your hours don't count — you'll just need to accrue hours in the right roles.

If you're coming to financial planning from another field, your experience likely doesn't qualify for CFP® certification — even if you've got an advanced degree or many years in that field. Everyone is required to earn 4,000 to 6,000 hours of personal financial planning experience.
