Accepted Delivery Models

CFP BOARD

Live presentation is defined as

- Real-time interaction between the instructor and participants
- In-person session
- Web Conferencing where attendance and engagement can be measured
- Self-Study is defined as
 - E-Learning; real-time interaction with the content
 - Delivered online through a system that will meet the required functionality covered in this document
 - Recognizes a pre-determined deadline for completion (as per CE Sponsors policy)
- Delivery methods no longer accepted:
 - Previously recorded content delivery
 - Unmonitored independent study

Self-Study (Online) Course Delivery



- Required progression through course material and successful completion of activities
- Activities imbedded after each module; may include but are not limited to:
 - Pop Up Quizzes
 - Case Studies
 - Access to the final assessment *only after* the course has been completed
- PDF of content can be made available
 - The course must still be completed online

Core & Supplemental Content

CFP BOARD

- CFP Board will provide
 - Learning Objectives
 - 100 minutes of required core content with script
 - Variety of exercises and case studies for sponsor to draw from
 - Assessment question bank
 - Guidelines for the course evaluation

CE Sponsor may

- Add supplemental ethics related content (total course time not to exceed 120 minutes)
- Add 2-3 questions to the assessment bank to cover this content
- Add a 3rd hour of content to satisfy requirements other than CFP Board Ethics (3rd hour can be registered separately as General CE)

Final Assessment

CFP BOARD

- Follows CFP Board CE Policy
 - 20 questions total
 - 70% passing score
- Test Bank provided by CFP Board
 - 40 questions based on learning objectives
 - 2-3 questions can be added by CE Sponsors to cover ethics related supplemental content

Online Capabilities

- Randomize assessment questions after each attempt
- Display total questions correct and incorrect after each attempt
- No display of correct response feedback without passing score
- Limit attempts to 3; before content review is required

Course Evaluation

CFP BOARD

Required for all Self-Study (Online) course completions

- Can be an online link to a course evaluation form or
- Questions added to the final Assessment as non-graded responses
- Provide the CE Sponsors the ability to summarized responses in a reportable format

Summary of responses must be provided to CFP Board when requested with a response summary for each question equal to the number of reported completions within a specified timeperiod



- Certificates of Completion will be made available to those scoring a 70% or higher on the assessment
- Certificate of Completion must include the CFP Board Program ID
- Attendance reporting will be completed within 14 days of course completion
